Offer

Master Lock will provide a \$1 rebate for every hanging combination padlock retired (regardless of brand) and shipped to the Master Lock Rebate Center, up to the number of new Master Lock® model 1525 BlockGuard® locks purchased in compliance with the Terms and Conditions (pages 6-8). *Specific minimums and dates apply:*

- Minimum purchase of 250 model 1525 BlockGuard® locks from an authorized Master Lock dealer between March 1st, 2010 and September 15th, 2010 and receive locks by September 30th, 2010
- Schedule a minimum return of 250 retired hanging combination padlocks to the Master Lock Rebate Center by October 29th, 2010.
 - Shipping of retired locks for this program is free of charge in the contiguous 48 United States
 - Shipments will only be accepted when arranged through Master Lock – see Step-By-Step Instructions (page 4)

Step- By- Step Instructions

1. Purchase at least 250 new Master Lock model 1525 BlockGuard® locks from an authorized Master Lock distributor between March 1, 2010 and September 15, 2010. Keep a copy of the *Purchase Order* – it will be needed as proof of purchase for rebate eligibility.
2. Take delivery of the new Master Lock model 1525 BlockGuard® locks no later than September 30, 2010. Keep a copy of the *Packing Slip* – it will be needed as proof of delivery for rebate eligibility.
3. After receiving the new Master Lock model 1525 BlockGuard® locks (step 2), complete the online *Rebate Contact Us Form*.

4. After filling out the online *Rebate Contact Us Form*, you will be contacted by a Master Lock Customer Care representative who will: (a) request *Proof of Purchase* and *Proof of Delivery* required in the Terms & Conditions nos. 1., 2., and 5. below; and (b) arrange shipment of a minimum of 250 retired hanging combination padlocks (regardless of brand) to the Master Lock Rebate Center. Shipment of the retired padlocks to the Master Lock Rebate Center must be scheduled with Master Lock no later than October 29, 2010.
5. Upon receipt of the retired hanging combination padlocks, Master Lock will verify compliance with the Terms & Conditions of the rebate program. If the Terms and Conditions are met, Master Lock will pay a One Dollar (\$1.00) rebate to the purchasing school or business for every Retired Lock shipped to the Master Lock Rebate Center up to the number of Locks purchased. Verified rebate claims will be paid by check within approximately 8 weeks of receipt of all required materials. Important Eligibility Dates

- New Master Lock Model 1525 BlockGuard® locks must be purchased from an authorized Master Lock dealer between March 1, 2010 and September 15, 2010.
- New Master Lock model 1525 BlockGuard® locks must be received by September 30, 2010.
- Shipment of a minimum of 250 retired hanging combination locks to the Master Lock Rebate Center must be scheduled with Master Lock no later than October 29, 2010.

Terms and Conditions

1. Between March 1, 2010 and September 15, 2010 purchase a minimum of 250 new Master Lock model 1525 BlockGuard® locks ("Locks") from an authorized Master Lock Distributor ("Qualified Purchase").
2. Receive Locks before September 30, 2010.
3. A minimum of 250 hanging combination padlocks ("Retired Locks") of any brand must be scheduled for shipment to the Master Lock Rebate Center, following the process in no. 5 below, no later than October 29, 2010. Retired Locks used in this rebate program will only be accepted through the Master Lock return authorization process set up for this rebate program. The return authorization process must be initiated online by completing the *Rebate Contact Us Form* accessible through the *Step-By-Step Instructions*.
4. Master Lock will pay a One Dollar (\$1.00) rebate to the purchasing school or business for every Retired Lock shipped to it up to the number of Locks purchased in compliance with these Terms & Conditions ("Rebate").
5. Within 2 business days of receiving a completed *Rebate Contact Us Form* a Master Lock Customer Care representative will initiate contact to arrange shipping of the Retired Locks to Master Lock. When instructed by Master Lock, the following information must be sent to Master Lock Customer Care by fax or e-mail a copy or PDF:
 - a. A copy of the *Purchase Order* for the Qualified Purchase that verifies all purchase requirements (see 1. above) by circling: (i) the number of Master Lock® model 1525 BlockGuard® locks that were purchased; (ii) the name and address of the purchasing school or business; and (iii) the name of the authorized Master Lock distributor; (iv) the date the Purchase Order was submitted; and
 - b. A copy of the *Packing Slip* from delivery of each Qualified Purchase that verifies that the Locks were received by September 30, 2010 by circling: (i) the date the Qualified Purchase was shipped; (ii) the number of Master Lock® model 1525 BlockGuard® locks that were shipped; and (iii) the name and address of the recipient school or business.

Terms and Conditions

6. Master Lock will pay for shipping of the Retired Locks to the Master Lock Rebate Center from only one (1) location within the contiguous 48 United States per school, business, name or address. Master Lock will not pay the shipping costs for shipment of the Retired Locks from Hawaii or Alaska or any other location outside the contiguous 48 United States.
7. Retired Locks must be packaged for shipping by the school or business at its own cost in packaging sufficient for carriage by a common carrier. Retired Locks lost in transit will be ineligible for the Rebate.
8. It is the responsibility of the school or business to be available for the scheduled pick-up of the Retired Lock shipment. Any carrier fees for a missed pick-up will be deducted from the Rebate amount.
9. Limit one (1) Rebate per school, business, name or address. Separate purchases by related entities (such as separate schools within a district) cannot be aggregated to qualify for the Rebate. Limit one (1) Retired Lock shipment per school, business, name or address.
10. Please allow up to 8 weeks following the shipment of the Retired Locks for verification of compliance with all Terms & Conditions and delivery of the Rebate. Rebate checks will be issued to the school or business named and location identified on the purchase order. Contact Master Lock at blockguardrebate@mlock.com if the Rebate is not received within 8 weeks of shipment.
11. Void where prohibited, taxed or restricted. Cannot be combined with any other offer. Offer valid in the U.S.A. only. Only schools and businesses are eligible for this offer.
12. New BlockGuard® model 1525 locks received under warranty or other no-charge conditions, or distressed sale are not eligible for this rebate.



