## MASTER LOCK "Protecting All That You Love and Care About" SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning a prize. This Sweepstakes is in no way sponsored, administered, endorsed or associated with Twitter. Twitter is not affiliated with the Sponsor in any way. By entering, you understand that you are providing your personal information to Master Lock Company LLC and not to Twitter.

**Content of Entry**: To be valid and eligible, Entries must adhere to the requirements and limitations set forth in this section.
